7. The deadline for new applications to be received by the Electoral Registration Officer to vote by proxy on grounds of a medical emergency is not later than 5pm on Thursday, 28th September 2017.
8. Applications to be added to the Register of Electors in order to vote at this election must reach the Electoral Registration Officer by Tuesday, 12th September 2017
